

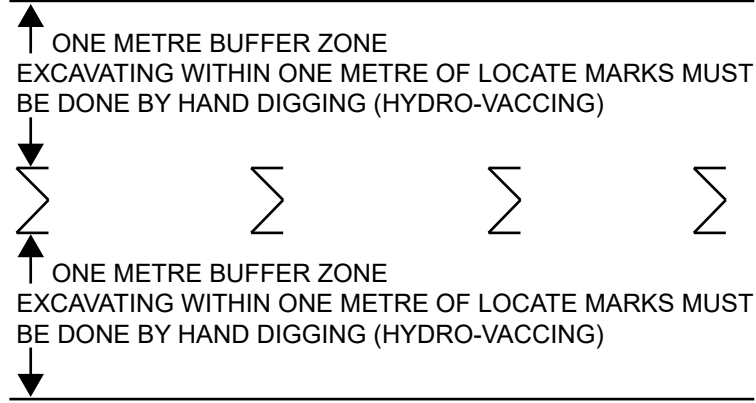
**SUPPLEMENTAL REPORT**

**Large Project Ticket Type valid for 60 days, all other Ticket Types are valid for 30 days!**

**\* \* \* EXCAVATOR CAUTION \* \* \***

THE LOCATE MARKS PROVIDED BY THE OPERATORS OF BURIED FACILITIES ARE TEMPORARY AND **IF THEY WILL BE DISTURBED OR DESTROYED BY THE GROUND DISTURBER'S ACTIVITIES, THE GROUND DISTURBER MUST PROVIDE MORE PERMANENT OR OFFSET MARKS OR REFERENCES THAT WILL NOT BE DISTURBED. GROUND DISTURBERS ARE TO REFRESH THE LOCATE MARKS USING THE MEASUREMENTS PROVIDED ON THE LOCATE SKETCH(S).** IF ANY DELAYS SHOULD OCCUR IN ACTING ON THE LOCATE INFORMATION AS GIVEN, OR SHOULD LOCATE SKETCH **NOT** COINCIDE WITH MARKS ON THE GROUND, A NEW LOCATE REQUEST MUST BE OBTAINED. ANY CHANGES TO LOCATE OR NATURE OF WORK REQUIRES A NEW LOCATE REQUEST. THE EXCAVATOR IS RESPONSIBLE FOR THE REMOVAL OF ALL THE FLAGS OR OTHER MARKS UPON COMPLETION OF EXCAVATION ACTIVITIES.

**LOCATOR'S PAINT MARKS**



A copy of the Primary, Auxiliary & Supplemental Locate Reports must be on site and in the hands of the machine operator during work operations. Should sketch and markings not coincide, a new locate **MUST** be obtained.

**You are RESPONSIBLE for DAMAGE caused to any facilities by your operations within 1 meter of the alignment of the locate marks independent of depth. By accepting this locate, you acknowledge and agree to ALL terms & conditions outlined !**

F.O.T.S. = Fibre Optic Transmission System

**ATCO Gas Policy:** Gas lines must be inspected by ATCO Gas prior to backfilling. Minor coating damage to natural gas lines must be reported and will be repaired free of charge. For this service, call your local ATCO Gas office. Government regulations prohibit the building of a permanent structure over a natural gas line. Gas lines can be relocated at the property owner's expense. **Any DAMAGE MUST be reported to ATCO Gas Emergency Dispatch: 1-800-511-3447** - PVC - ATCO Gas must be notified when excavation is within 5m of PVC pipeline, contact Damage Prevention at 1-800-511-3447.

**FortisAlberta Policy:** The Owner/Occupier **shall not dig or excavate within 1 meter** of the area which the locator has indicated contains Facilities unless and until FortisAlberta has provided its written consent to the excavation work and the method to be employed. For consent, contact the local FortisAlberta office at 310-WIRE (9473). **Any DAMAGE OR SUSPECTED DAMAGE MUST be reported to Alberta One-Call at 1-800-242-3447 by the ground disturber.**

**TELUS Policy:** Hand expose or hydro-vac to the depth of your excavation within 1 meter of ALL TELUS facilities including TELUS FOTS (Fibre Optic Transmission System). **Any DAMAGE MUST be reported to Alberta One-Call immediately @ 1-800-242-3447.** If excavating on Private Property near a TELUS easement, contact crossings@telus.com for a Crossing Agreement **PRIOR** to working within 5.0 meters of Fibre Optic Transmission System.

**ATCO Pipelines Policy:** **Any damage to ATCO Pipelines facilities, including minor coating damage must be reported to ATCO Pipelines IMMEDIATELY @ 1-877-496-9380.**

**AGREEMENT / NOTIFICATION REQUIREMENTS:**

- No work, ground disturbance, pipeline crossing or structure placement to take place within 5 meters of the pipeline or on the ATCO Pipelines right-of-way without an ATCO Pipelines written Agreement.
- ATCO Pipelines must be notified in writing of any ground disturbance taking place within the area identified as the controlled area ie. between 5 to 30 meters of the pipeline.

**ATCO Electric Policy:** The Owner/Occupier **shall not dig or excavate within 1 meter** of the area which the locator has indicated contains Facilities unless and until ATCO Electric has provided its written consent to the excavation work and the method to be employed. For consent, contact 855-623-1982 between 8:00AM and 4:00PM regular business days. **Any DAMAGE OR SUSPECTED DAMAGE MUST be reported to Alberta One-Call at 1-800-242-3447 by the ground disturber.**

**ENMAX Policy:** Before performing a ground disturbance within 5 meters of Transmission Infrastructure, 2 meters of any above ground Structure (including Transformers, Poles, Pull Boxes, Manholes, etc.) or 1 meter of any other ENMAX Infrastructure, you must receive permission from ENMAX by calling 403-514-6100 or emailing hotdigs@enmax.com
